CEUs (or PDPs) for Social Workers, Educators or LMHCs

Metropolitan Mediation Services offers 36 hour Certificate Programs of training in mediation – an Alternative Dispute Resolution practice for achieving collaborative, voluntary resolution of disputes. MMS has been training attorneys, social workers, municipal officials, HR staff, educators, business people, police officers, and many others in mediation for 30 years.

The Training

Participants will receive thirty-six hours of conceptual and hands on training targeted to building the following skills:

- ♦ Understanding the dynamics of conflict
- ♦ Communication skills, such as neutral presentation and active listening.
- ♦ Eliciting and transmitting offers and information.
- ♦ Addressing issues of power and balance.
- ♦ Creating Strategies for Agreement

The training consists of:

- ♦ Demonstration of a mediation for observation.
- Presentations and discussions about concepts of dispute resolution.
- ♦ Exercises to illustrate and build skills.
- Nine supervised role play mediations with individual feedback and group debriefings.
- ♦ Large and small group discussions and exercises.
- ♦ Individual evaluation of each trainee.

Materials

Participants will receive a binder of training materials; the book *The Mediators Handbook* (Included in your tuition! List price: \$24.95); articles and handouts, and, upon successful completion, a certificate of training.

Dates and Times

A training fills two weekday evenings, two full Fridays and two full Saturdays. Full attendance is required.
