Duties:

- Communicate with patients' relatives, collaterals, and fellow professionals in the community to develop and implement treatment plans
- Provide physical health screening and primary health care monitoring
- Provide clinical consultation to peers and other health care professionals.

Qualifications:

Current licensure in the Commonwealth of Massachusetts as an adult psychiatrist. At least one year of post-residency experience is highly desirable.

Hours and Location:

The position is based in our outpatient office in Brookline and the Cedar Clinic in the Longwood medical area. The hours are 16-20 hours per week (Monday to Friday), of which 65% will be face-to-face direct patient care and includes one evening (until 8 PM). Treatment can be provided both on-site as well as through our telehealth platform.
