The Gifford School is a private, nonprofit co-educational day school in Weston, MA, providing a specialized educational and clinical program for students who face a variety of learning, behavioral and/or emotional challenges. Gifford serves over 100 students ranging from eight-year-olds to high school seniors. Students come from over 60 cities and towns throughout Massachusetts.

- Provide school-based child evaluations and psychotherapy to students at the Gifford School.
- Maintain caseload of 15 child clients made up of elementary, middle, and high school students
- Attend meetings including IEPs and weekly school case consults providing staff with therapeutic input

Provide consultation to teachers and other therapeutic school staff

- Provide intake and diagnostic assessments for new clients
- Develop treatment plans in accordance with regulations and agency policy
- Provide individual, group, and/or couples and family counseling
- Collaborate with collateral contacts and other providers
- Complete documentation as required in a timely manner
- Provide clinical supervision for junior clinicians
- Participate in teams, committees and/or task forces as appropriate
- Provide consultation to staff at 1-2 Brookline Public Schools

- Independent licensure in the state of Massachusetts (Licensed Psychologist, LICSW, LMHC, LMFT)
- Excellent interpersonal, organizational, and clinical writing skills.
