The candidate would split their time providing outpatient psychotherapy to Center clients and responding to the clinical needs of residents living at the Brookline Housing Authority (BHA) providing assessments, short-term clinical interventions, consultation and care coordination when needed. The ideal candidate would have experience of working with individuals, families and diverse populations.

This is an excellent opportunity for a clinician who is looking for a collegial setting with wonderful co-workers and a broad set of related services. The Brookline Center has a strong commitment to training and professional development. The Clinician would report to the Community Services Manager, receive supervision and can participate in a variety of seminars, lectures, and other professional development activities.
